

## Privacy Policy

Applixation Kft. (Address: 126-128 Bécsi út, Budapest 1034, Hungary, VAT number: 25453876-2-41) referred to herein as "Applixation" is aware of and respects the privacy rights of the users of its websites (applixation.hu, logicort.hu, medicort.hu, salecort.hu, shopcort.hu). Any personal information given to us will only be used for the purpose of responding to quotation requests.

We only use personal information that is necessary for accomplishing said goal, and we only use it for the time and to the extent necessary for doing so. Applixation will protect all personal information acquired through its websites by all means reasonably expected of it.

**Legal basis of using personal information:** Act CXII of 2011 on the Right of Informational Self-Determination and on Freedom of Information, Section 5, (1) a) consent of the data subject.

By requesting a quotation the user gives his explicit consent for Applixation to use his provided personal information as detailed in the current guidelines.

**Data subjects involved:** Users requesting quotations.

Purely visiting our websites will not require the user to submit any personal information (other than what is automatically processed by technology).

**Personal information specified:** Data necessary for contacting users requesting quotations: email address, phone number, name, message.

When the websites are viewed, some information related to the user is collected automatically by the system. A time log of the visit is always created and in some cases the details of the user's browser and operating system are also recorded, along with his IP address and the name of the site he arrived from. This information is only used to generate statistics, and in no way does it get connected to any other personal data submitted.

**Goal of collecting personal information:** To be able to respond to quotation requests.

**Persons authorized to view the personal information:** The employees of Applixation and affiliates marketing its services.

**Duration of storing personal information:** The personal information will be stored until the user formulates a legitimate demand to delete it.

**The user may request from Applixation:**

- to provide information on the use of his personal information,
- to correct or change his personal information,
- to delete his personal information or stop its further use.

The requests may be submitted to us by email or by phone and we will respond to it in a clear and concise manner as soon as possible, within 10 working days at the latest. We will state our response in writing if the user so wishes. If we deem the request of the user legitimate, we will correct or delete the personal information without delay. Should the user not be satisfied with Applixation's response, he may enforce his right to protected personal information in civil court, or may turn for help to the National Authority for Data Protection and Freedom of Information ([www.naih.hu](http://www.naih.hu)).
